# 3. PLACE AND RECIPIENTS OF DATA PROCESSING

Processing related to the web services offered by this site is carried out at the headquarters of the operating company of the data controller and is handled only by employees, collaborators or partners of Sensitron s.r.l. in charge of processing or, if necessary to partners, employees and collaborators of companies related to or participated in by Sensitron s.r.l., or by any persons in charge of occasional maintenance operations, the latter under the close supervision of the data controller. No data resulting from the web service is communicated or disclosed to third parties, except in the cases and forms provided for by applicable law. In fact, personal data may be

communicated at the request of the police or public authorities and state administrations for purposes related to the fulfillment of legal obligations, for reasons of investigation, verification, and repression of administrative, fiscal, accounting, tax and criminal offenses. Sensitron S.r.l. is part of the Halma Group. Where necessary to execute a request or issue raised by the user, personal data may be disclosed to the parent company Halma Plc or other companies in the Halma Group. Where such disclosures would involve a transfer of data beyond the territory of the EU, this would be done only with the safeguards provided by Article 46 GDPR.

# 4. TYPES OF DATA PROCESSED AND PURPOSE OF PROCESSING

#### DATA VOLUNTARILY PROVIDED BY THE USER

Sensitron S.r.l. collects the user's identification data, such as: first and last name, email address, telephone, city, company for which the user works and chosen password as well as other personal information that the user voluntarily decides to provide to Sensitron S.r.l. when the user registers in the Reserved Area of the site and subsequently with the exchange of correspondence. The purpose of such collection and subsequent processing is to fulfill requests for information and contact from the registered user.

With reference to messages and questions received from registered users, Sensitron S.r.l. invites its users, to respect the principle of necessity and minimization of data and, therefore, not to send names or other personal data of third parties that are not strictly necessary. Where the registered user has provided his or her express consent in the forms provided for when registering on the site (or in any other way in the conso of the contacts made with the company) Sensitron S.r.l. may process the user's data to send him or her marketing and promotional communications regarding, for example, Sensitron products and/or services, as well as to contact him or her in relation to training opportunities and invite him or her to participate in events. It is understood that, regardless of express consent, Sensitron S.r.l. may send advertising emails for products and services similar to those for which the user has requested information, unless the data subject opts out and asks not to receive any more information.

#### DATA HOWEVER COLLECTED WHILE BROWSING THE SITE

Sensitron S.r.l. also processes other personal data of users, including non-registered users, who visit the site for the sole purpose of enabling access to the web pages and contents of the site as well as the use of the services provided therein.

The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols.

This is information that is not collected to be associated with identified interested parties, but which by its very nature could, through processing and association with data held by third parties, allow users to be identified.

This category of data includes the IP addresses or domain names of the computers used by users who connect to the site, the URI (Uniform Resource Identifier) notation addresses of the resources requested, the time of the request, the method used in submitting the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters relating to the user's operating system and computer environment.

These data are also used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning and are deleted immediately after processing. In this case, Sensitron S.r.l. is not obliged to ask for the user's consent, this activity being within its legitimate interest and being balanced with the protection of the user's data through an appropriate accountability system.

Personal data processed by Sensitron S.r.l. could be used for the investigation of civil and criminal liability of the user or third parties against Sensitron S.r.l.

# 5. COOKIES

No use is made of cookies for the transmission of information of a personal nature, nor are so called persistent cookies of any kind, i.e., systems for tracking users, used.

The use of session cookies (which are not stored persistently on the user's computer and disappear when the browser is closed) is strictly limited to the transmission of session identifiers (consisting of random numbers generated by the server) necessary to enable the safe and efficient exploration of the site. These are therefore technical cookies that do not require users' consent. The session cookies used on this site avoid the use of other computer techniques potentially prejudicial to the confidentiality of users' browsing and do not allow the acquisition of personal data identifying the user.

# 6. OPTIONALITY OF PROVIDING DATA

# 7. MODE OF PROCESSING AND STORAGE OF PERSONAL DATA

Personal data are processed by automated means for the time strictly necessary to achieve the purposes for which they were collected. Specific and adequate security and organizational measures are observed to prevent data loss, illicit or incorrect use and unauthorized access.

In particular, registered user identification data will be stored as follows: -

• For a period of 2 years in relation to the preservation of the requests made and the answers provided to protect the integrity of the same and possible claims for compensation by the interested party, without prejudice to the longer period of preservation related to potential orders placed by the user and the establishment

### 8. RIGHTS OF INTERESTED PARTIES

The subjects to whom the personal data refer have the right at any time to obtain confirmation of the existence or non-existence of the same data and to know its content and origin, verify its accuracy or request its integration or updating, or rectification, in accordance with current regulations. Pursuant to current legislation, the interested party/user has the right to request the deletion, transformation into anonymous form or blocking of data processed in violation of the law, as well as to oppose in any case, for legitimate reasons, their processing. Any consent expressed to the processing of personal data for marketing and advertising purposes may be freely revoked at any time without any consequence on existing business relations with Sensitron S.r.l.
